1 Pending before the Court is Plaintiff Carmen Terry and Defendants
2 JPMorgan Chase Bank, N.A. and Real Time Resolutions, Inc.’s Joint Motion to
3 Reset Final Approval Hearing Date and Related Settlement Deadline (the
4 “Motion”).

5 Upon review of the matter, the Court **GRANTS** the Motion, and resets
6 certain deadlines stated in its Order Granting Unopposed Motion for Preliminary
7 Approval of Class Action Settlement (the “Preliminary Approval Order”) (ECF
8 No. 55). The Final Approval Hearing shall be continued by fourteen (14) days,
9 from January 5, 2018 to January 19, 2018, at 1:30 p.m., in Courtroom 13A (13th
10 Floor) of the United States District Court for the Southern District of California,
11 located at 333 West Broadway, San Diego, California. The Parties’ deadline to
12 file briefs in response to objections and in further support of final approval and
13 attorneys’ fees shall be continued by two weeks, to January 12, 2018. All other
14 dates and deadlines shall remain calculated pursuant to the original schedule set
15 forth in the Preliminary Approval Order (ECF No. 55).

16 Accordingly, pursuant to the Motion and Preliminary Approval Order, the
17 following dates and deadlines shall apply:


